#### 6. Questions on the Reports Presented

1) Asked by Colin Boothman. "Why are you carrying such high reserves?"

Answer – The reserve fund is much higher than we feel is required and we are looking for worthy projects which we can support.

Plans for a second and third film have not yet matured but are still being considered.

The Committee is currently short staffed and this has had an impact on our ability to put energy into projects.

We are currently in advanced stages of creating a new Local Tourist Map Trail for which funding will be required (£1000 max.)

2) Asked by Colin Boothman. "Would we consider using funds for charitable grants?"

Answer – Yes, we are willing to consider the use of funds for such schemes that further the aims and aspirations enshrined within the Constitution.

3) Asked by Margarie Hanson. "You mentioned a new Tourist Map Trail. Can you explain?"

Answer – We are currently running down stocks of the existing map prior to going into print of the new map. The new map is in its final editing stages and will include new information like a list and location of all current and historic hostelrys within the town together with data on each accessed via Q.R. codes.

4) Asked by Ken Humphris. "Many people in the town feel that the C.S. involvement within the Town Planning process is very important. Can the C.S. consider improved ways of keeping members informed on Planning Comments?"

Answer – We do provide a resumé, on the C.S. web site, of all Planning Applications upon which comments have been made. Whilst this doesn't provide a great amount of detail, it does give an indication of our views. We are mindful that not everyone has access to such on-line data and will consider this matter further.
