

Planning applications reviewed from November to January 2018/19

The following new application was submitted to SLDC

SL/2019/0007 **Fairbank Cottage Kirkby Lonsdale LA6 2BD** Installation of front and rear dormers, internal alterations and conversion of coach house to living accommodation, to include new door to front elevation and glazed doors to rear elevation. KLDCS has objected to the addition of dormer windows to this listed Georgian house, and has requested a more restrained approach to the new glazed infill to the two large coach house doors.

SL/2018/1007 **Lupton Hall Lupton LA6 2PX** A micro scale Anaerobic Digester to generate renewable energy from waste slurry

SL/2018/1014 **Tarnside Lupton LA6 2PP** Alterations and extensions to existing builder store to form live to work unit

SL/2018/1031 **land opposite Meadowside, Lupton LA6 1PJ** two dwellings

SL/2018/1030 **16 Main Street Kirkby Lonsdale LA6 2AE** Installation of a period style outdoor light above front door

SL/2018/1029 **Queen Elizabeth School, Kirkby Lonsdale LA6 2HJ** new entrance and perimeter fencing

SL/2018/1023 **Garden Cottage, High Biggins Kirkby Lonsdale LA6 2NP** Proposed new internal staircase to access existing attic rooms, 3No new conservation style velux roof windows and internal re-modelling in attic areas

SL/2018/1016 **Beech House, High Biggins Kirkby Lonsdale LA6 2NP** Proposed internal alterations, new windows to rear and gable elevations and 5 No. new conservation style velux roof windows, garden re-modelling in rear garden area.

SL/2018/0961 **Hying House Low Biggins Kirkby Lonsdale LA6 2DH** Application to change the use of land from agricultural use to garden use

SL/2019/0016 **Lupton Hall, Lupton LA6 2PX** Erection of concrete ring slurry store
