

Planning applications reviewed from July to Aug 2021

The following new applications were submitted to SLDC, KLDCS had no comment-

SL/2021/0803 **Middle Row Farm House Lupton LA6 2PZ** Alterations to include a 2 storey rear extension to replace existing single storey rear extensions (Resubmission SL/2020/0945)

SL/2021/0795 **Kirkby Lonsdale Play Park Kirkby Lonsdale LA6 2AD** Re-location of existing pedestrian access to play park

CU/2021/0008 **Barns at Foulstone Lupton LA6 2PP** Application to determine if prior approval is required for a change of use of 3 agricultural barns to 4 dwellings

SL/2021/0735 **Plot 2 Land North of Biggins Hall High Biggins Kirkby Lonsdale LA6 2NP** Single dwelling

SL/2021/0727 **Kirkby Motors, Kendal Road Kirkby Lonsdale LA6 2HH** Demolition of existing vehicle spray booth structure and erection of a dark grey steel portal framed building for MOT vehicle testing

SL/2021/0716 **Biggins Hall High Biggins Kirkby Lonsdale LA6 2NP** Replacement windows

SL/2021/0433 **Beech House Foulstone Lupton Kirkby Lonsdale LA6 2PP** Repair of roof

The following new application was submitted to YDNP.

S/04/30 **Smithy House, Barbon, LA6 2LJ** Householder application for demolition of existing uPVC porch/conservatory and construction of new two storey extension to provide porch with bathroom above, re-form existing lean-to garage roof, external alterations to various window/door openings, removal of chimney, new first floor balcony to west elevation and internal reconfiguration.

KLDCS has objected to aspects of this application, in particular, the inappropriate window treatment generally, the tall modern gable window, and the introduction of a glass balcony. KLDCS believes these to be incongruous in this traditional and prominent village setting.

S/04/11B **Chapel House, Barbon, LA6 2LR** Section 73 application for variation of Condition 2 and 7 of S/04/11A (full planning permission for conversion of former Methodist Chapel to form single dwelling; installation of package treatment plant; change of use of land from agricultural to domestic use for parking, turning area and garden) in respect of amended plans and obscure glazing specification

S/05/35, **Casterton, Kirkby Lonsdale, LA6 2SF** Householder planning permission for replacement of single storey side element with a two-storey extension.

S/11/18A **High Green Farm, Middleton in Lonsdale, Cumbria, LA6 2NA** Full planning permission for erection of building to roof over the existing slurry store

S/11/14C **Bainsbank, Middleton, LA6 2NG** Full planning permission for erection of new covered midden

S/09/8B/LB **Underley Home Farm, Underley Business Centre, Kearsywick, LA6 2DY** Listed building consent for conversion of existing agricultural buildings to create cafe, estate shop, office, workshop and leisure spaces
